



PetroPlus® and the Climate Challenge




To monitor compliance. PetroPlus® has implemented a robust system for screening and evaluating potential business partners, ensuring they meet our rigorous standards for responsible business practices. Understanding and managing sustainability risks in our supply chain is a key priority for PetroPlus®. We use a comprehensive country risk assessment methodology to evaluate the sustainability challenges in the regions where we operate. This tool, developed by industry leaders, helps us identify areas with heightened sustainability risks, such as human rights concerns, labour practices, environmental impacts, and political instability. Based on these assessments, PetroPlus® maintains an up-to-date risk categorization. which auides decision-making. Our assessments also identify regions where operations may be restricted due to concerns like trade sanctions, conflicts, and other critical risks, enabling us to prioritize responsible sourcing and mitigate potential impacts.

Effective management of health and safety

At PetroPlus®, the effective management of health and safety, the environment, human rights, and community engagement (collectively referred to as "HSEC") is fundamental to our mission of sustainable and responsible business growth. We place the utmost priority on safeguarding the health, well-being, human rights, and safety of our employees, customers, and the communities we serve. Similarly, we are committed to protecting and respecting the environment in all regions where we operate. In 2022, PetroPlus® achieved its health and safety objectives while making substantial progress in reducing the frequency and severity of process safety incidents. Every incident is thoroughly investigated, with lessons learned shared across all operational units to promote a culture of continuous improvement and accountability. PetroPlus® recognizes that many of the products we trade, particularly fuels, are highly flammable and may present additional risks, such as the carcinogenic properties of certain naphtha products.

To ensure the safe handling of these materials, PetroPlus® communicates hazard information. precautionary measures, and risk management guidelines to clients through Safety Data Sheets (SDS). These SDS documents comply with globally harmonized standards established by the United Nations and adhere to regional regulations such as REACH in Europe and the Hazard Communication Standard in the United States. In jurisdictions like the European Union, products are marketed only after comprehensive registration dossiers are submitted, including data on human health and environmental hazards. Our extensive SDS library supports compliance and safety in multiple regions, while our REACH registrations enable the responsible manufacturing or importation of petroleum substances and biofuels. Through training, procedures, and audits, PetroPlus® ensures regulatory compliance and, as of now, has reported no incidents related to product safety management.
